Privacy Notices – BVC P&FA

Who we are:

For the purposes of Data Protection legislation, the Bassingbourn Village College Parents and Friends Association (BVC PFA) is the Data Controller. This means it is in charge of personal data about you.

In this policy 'we' and 'us' means the PFA.

How we use your information:

We process personal data relating to our Committee members and those that attend our meetings. This is for the purpose of building community, through social opportunities, fund raising, information-giving and being a link and means of communication between parents and the school.

The personal data includes identifiers such as names and contact details. It does not include sensitive personal data such as ethnic group and medical information.

Collecting and using your information in this way is lawful because:

- The processing is necessary for the performance of our aims which is a legitimate interest.

When we collect personal information on our forms, we will make it clear whether there is a legal requirement for you to provide it. If there is no legal requirement then we will explain why we need it and what the consequences are if it is not provided.

How we share your information with third parties:

We will not share information about you with third parties without your consent unless the law allows us to.

With Consent

We may contact you to inform you of other types of events being held that you may be interested in or for research purposes, but only where consent has been provided to this.

How long we keep your personal information:

We only keep your information for as long as we need it or for as long as we are required by law to keep it.

Your rights:

You have the right to:

- Ask for access to your personal information
- Ask for rectification of the information we hold about you
- Ask for the erasure of information about you
- Ask for our processing of your personal information to be restricted
- Data portability
- Object to us processing your information.
